A rapidly-growing number of theoretical approaches and empirical studies characterize the sociology of law. Now a comprehensive text-reader brings together these divergent strands in a systematic introduction to the study of law in society.

The Sociology of Law features 40 articles by leading social scientists and legal scholars who present a range of alternative theoretical approaches: behavioral, functional, jurisprudential, conflict, and systems-theoretic.

The book consists of seven parts:

I. Defining the Sociology of Law. II. Alternative Theoretical Perspectives. III. Social-Structural Theory of Law: Normative Analysis. IV. Social-Structural Theory of Law: Role Analysis. V. Social-Structural Theory of Law: Organizational Analysis. VI. Social-Structural Theory of Law: Interinstitutional Analysis. VII. Legal System Failures and Planned Social Change.

The major part of the book is a large scale exposition of a social-structural model of the sociology of law, informed by systems theory and Parsonian theory. The model is applied to such substantive areas as the courts and the judiciary on four levels of analysis: normative, role, organizational, and institutional.

A unique feature of this book is a set of appendixes of legal documents that illustrate legal reasoning and decision making.

Wide ranging in theory as well as research, and rich in historical and cross-cultural material, *The Sociology of Law* provides students, teachers, and scholars with a valuable sourcebook for understanding the relationship of law to society.

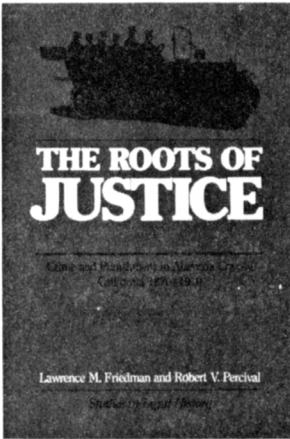

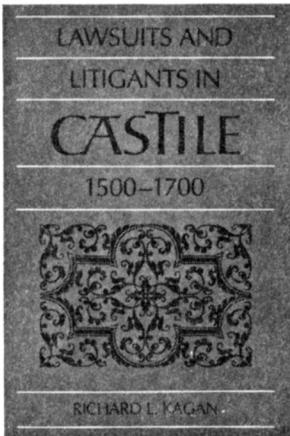
