Why do the inhabitants of Wales, Scotland and Ireland persist in maintaining an ethnic identity opposed to England? In addition, he considers and develops two models of post-industrial core-periphery interaction. Hechter's findings, as a case study of internal colonialism, have important comparative implications, suggesting that internal colonialism may be the model form of national government.

The reign of Edward IV began with his forcible seizure of the throne; it was punctuated in mid-term by his deposition, exile, and subsequent recovery of the throne, again by force. In this study of power-politics in fifteenth century England, Professor Ross portrays Edward IV neither as "a man vicious far beyond anything that England had seen since the days of John," as the Victorians saw him, nor as the totally astute, able ruler modern scholars have described. Rather we are presented with a monarch at once more fallible, more impulsive, more inconsistent, and less far-sighted than modern estimates depict him.

Written with free access to official documents, these volumes represent the first peacetime history to be authorized for publication. *Volume 1, Policy Making*, focuses on the administrative and constitutional machinery, and the strategic, political and international considerations that molded Britain's atomic policy. Of special interest is the analysis of the negotiations for Anglo-American atomic collaboration, and the effects of these negotiations on Britain's relations with Europe and the Commonwealth. *Volume 2, Policy Execution*, studies the costs of the project, in money and manpower, and the problems of safety, security and internal diplomacy. The chapters emphasize the great influence of the many unique personalities involved in this most unique period in British history.

The Journal of British Studies, founded in 1961, is published at Trinity College under the auspices of the Conference on British Studies. It was the result of the imaginative generosity of a Trinity alumnus, Frederick E. Hasler (Hon. LL.D. 1957) who contributed funds to the College for the specific purpose of establishing a learned periodical in the field of British history. Several Trinity alumni subsequently contributed to the fund and Trinity College now supports the publication of the *Journal*.

The Conference on British Studies is the official organization in the United States and Canada of scholars working in the field of British history and culture; its status as such is recognized by the American Historical Association of which it is an affiliate. Its nearly eight hundred members are drawn from fifty states and five provinces. It convenes twice each year, usually at New York University. The Conference awards a prize every five years for the best first book by an American or Canadian scholar.

The Conference sponsors a considerable publications program. It publishes the *Journal of British Studies* at Trinity College; the *British Studies Intelligencer*, a newsletter, at Western Washington State College, Bellingham, Washington; and *Archives in British History and Culture*, a series devoted to the publication of documents, at West Virginia University, Morgantown; and *Current Research in British Studies*, a quadrennial survey of research in progress in the United States and Canada, published at Kansas State University, Manhattan, Kansas and edited at Western Washington State College. The Conference also sponsors a series of short monographs, *Studies in British History and Culture*, edited at Wittenberg University, Springfield, Ohio and published by the Shoe-String Press, Hamden, Connecticut. Under the aegis of the Conference, Cambridge University Press publishes a bibliographical and biographical series. *Albion*, including the proceedings of the Conference in its regional and national meetings, is published at Appalachian State University, Boone, North Carolina, and is sent to all members of the Conference.

In addition to the Conference on British Studies, there are several affiliates: the Pacific Coast Conference on British Studies, Pacific Northwest Conference on British Studies who publish *Albion* twice a year, the Midwest Conference on British Studies, the Southern Conference on British Studies, and the New England Conference on British Studies. Each of these vital autonomous groups has its own officers, programs, and other activities. There are also local groups centered in Los Angeles, Detroit, Pittsburgh, and San Francisco.

The Journal of British Studies appears twice in the academic year, in the autumn and in the spring. The annual subscription is \$6.00. CONFERENCE ON BRITISH STUDIES PRIZE

The Conference on British Studies will award its fifth quinquennial prize of three hundred dollars in November, 1974. The prize will be given for the best book published between January 1, 1969 and December 31, 1973, by an American or Canadian scholar. It must be the author's first book. Its subject must lie either within the field of British or Commonwealth History and Culture.

Nominations should be sent to Professor Thomas Peardon, Bridgewater, Connecticut, Chairman, Conference on British Studies Prize Committee. Other committee members are R. J. Brentano, University of California, Berkeley, and H. J. Hanham, Massachusetts Institute of Technology.

The past recipients of the prize were: Philip P. Poirier, Ohio State University, 1960; C. Warren Hollister, University of California, 1963; Melvin Richter, Hunter College, 1966; Isaac Kramnick, Yale University, 1969.
