Studies in American Political Development is indexed in Social Science Citation Index, Sociological Abstracts, and International Political Science Abstracts.

Authors should send three copies of their manuscripts (double spaced), which will not be returned. After initial screening by the editors, selected manuscripts will be reviewed anonymously. Publication decisions will be made with regard to the overall composition of each issue. Cambridge University Press provides 25 free offprints to authors of published articles.
