CONTRIBUTORS

MARTIN BROWN is assistant professor of economics at Howard University. He received his Ph.D. in economics from the University of California, Berkeley, in 1981. He is the coauthor, with Peter Philips, of "The Evolution of Labor Market Structure: The Case of California Canning," *Industrial and Labor Relations Review* (1985) and has applied the historical approach to labor economics in several other industry case studies.

SANFORD M. JACOBY is associate professor of industrial relations at the UCLA Graduate School of Management. He received his Ph.D. in economics from the University of California, Berkeley. His publications include *Employing Bureaucracy: Managers, Unions, and the Transformation of Work in American Industry, 1900–1945* (1985), which received the George R. Terry Book Award from the Academy of Management. He is presently conducting a historical study of employee associations and independent unions.

PETER PHILIPS is assistant professor of economics at the University of Utah. He received his Ph.D. in economics from Stanford University in 1980.
