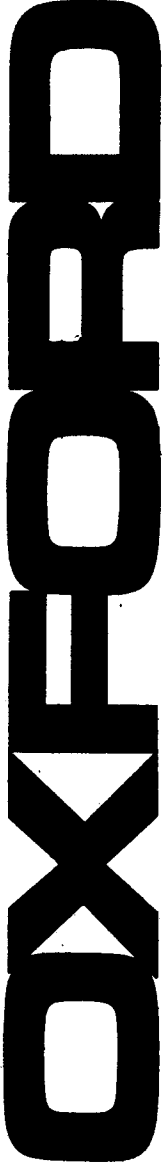

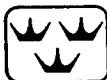

ROBERT R. BOWIE, Harvard University. Egypt's nationalization of the Suez Canal in July 1956 set off a series of political reactions that led to the invasion of the Egyptian Sinai Peninsula by Israeli troops in October, the bombing of towns along the Suez by the French and the British, and the landing of French and British troops in the Suez area. Although international law did not prevent the use of force, Professor Bowie argues that it was a major element affecting the actions and policymaking of the Egyptians, Israelis, British, French, Americans, Russians, and other Canal users.

Professor Watson here combines his knowledge of a variety of legal systems with a fine sense of history in an effort to deal with a series of fascinating jurisprudential questions. In what ways, he asks, is the development of a particular legal system influenced by the existence of other (foreign) ones? When does "borrowing" occur and how successful is it likely to be? By what means are the ideas and institutions of one legal system "transplanted" in another? Watson uses specific examples, in which slightly different "relationships" exist between two or more legal systems, to demonstrate that comparative law, properly conceived, can teach us much about the way law grows and legal systems develop.
