ERHARD BLANKENBURG is Research Fellow at the International Institute of Management at Berlin. He was formerly with the PROGNOS Corporation of Basle and with the Max-Planck Institute for International Penal Law in Freiburg, where he conducted studies of civil court proceedings and of state prosecutors in Western Germany. His specialties are Sociology of Law and Political Sociology.

BLISS CARTWRIGHT is Assistant Professor of Sociology at the State University of New York at Buffalo. He is currently working on a study of the flow of business in state supreme courts from 1870 to 1970.

JEFFREY FITZGERALD is a lecturer in Sociology and Legal Studies at La Trobe University, Melbourne, Australia. He spent five years at Northwestern University (1966-1972), obtaining an LL.M. and a Ph.D. in Sociology. He teaches courses on law and sociology, prisons, and legal controls of government officials. His current research is upon the legal profession in Australia and upon social processes within penal institutions.

He is currently engaged in studies of the consumer complaint process and of the deterrent effect of drinking-and-driving legislation in Scandinavia.
