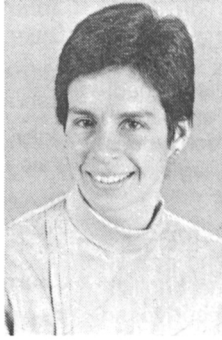

APSA has announced eight winners in the national competition for the 1983-84 Congressional Fellowship Program.

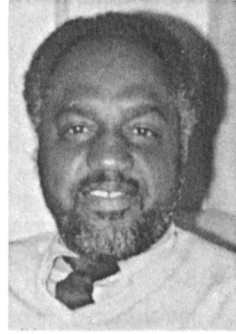
The winners—five political scientists and three journalists—will come to Washington, D.C. for a year of full-time work in the offices of U.S. senators and representatives.

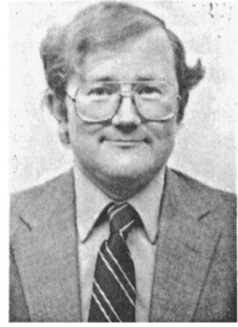

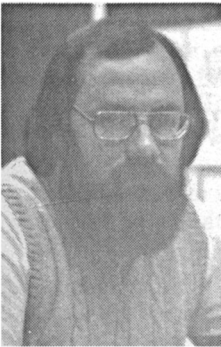

## People in Political Science

Sponsored by the Association since 1953, the purpose of the Congressional Fellowship Program is to give outstanding political scientists, journalists, medical faculty and federal agency executives an opportunity to acquire a rich understanding of the national legislative process.

The 977 alumni of the program include university presidents, deans and professors, newspaper and magazine publishers, editors and reporters, executives in the federal bureaucracy, and congressmen and congressional staff aides.

The Congressional Fellows are scheduled to arrive in Washington in early November for an orientation period before beginning work in Congressional offices of their choice. The program ends August 17, 1984.

The eight winners, listed below, were selected on the basis of professional experience, superior academic training, career goals and interest in national politics. Other Congressional Fellows, including health policy and federal executive fellows, will be announced later this year.
