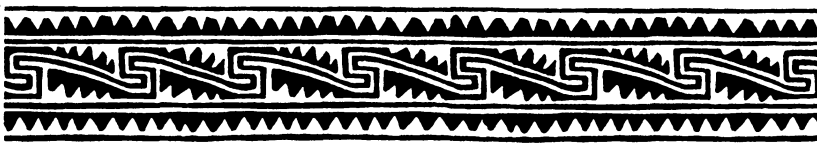

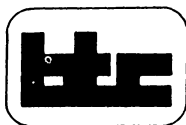

**GEORGE IRVIN** is Associate Professor of Development Economics at the Institute of Social Studies, The Hague, The Netherlands. The author of various studies on development planning issues in Latin America, he is currently economic advisor on Central American affairs to the Directorate General of the Commission of the European Community.

He has coauthored several books on Mexican agriculture, the most recent being *El fin de la autosuficiencia alimentaria* (with Blanca Suárez).

**BILLIE R. DEWALT** is Professor and Chair of the Department of Anthropology and Professor of Rural Sociology at the Patterson School of Diplomacy at the University of Kentucky, Lexington.
