#### Cover: Oil and Diplomacy in the Middle East

In the wake of the Middle East's partition after the First World War, as the great powers and their oil companies maneuvered for position in the region, international diplomacy and business interests intersected in a complicated series of negotiations designed to defend company and national preferences and to maximize control over the oilfields to come. Shown on our front cover is one of the principal players in this story, Walter Teagle of Jersey Standard, posing in 1917 at Standard Oil's New York office in front of the rolltop desk formerly used by John D. Rockefeller. Our back cover depicts Baba Gurgur no. 1, the discovery well at Kirkuk that came in in October 1927, providing members of the Red Line consortium with the first tangible evidence of the field's great potential.

# CONTRIBUTORS

H. S. Ferns, recently deceased, was professor of history emeritus at the University of Birmingham, where he also was associated with the university's Institute for Advanced Research in the Humanities after his retirement. Canadian by birth, he was the author of several books and other publications on Argentine history, including "Britain's Informal Empire in Argentina, 1806–1914," Past and Present (1953), Britain and Argentina in the Nineteenth Century (1960), and The Argentine Republic, 1516–1971 (1973).

Edward Peter Fitzgerald, who received his Ph.D. from Yale University, is associate professor of history at Carleton University in Canada. He has published several articles on the political economy of French overseas expansion, including "Did France's Colonial Empire Make Economic Sense?" Journal of Economic History (1988). He has recently analyzed the corporate struggle between Chevron and the Red Line consortium in Saudi Arabia (International History Review, 1991), and his study of French oil diplomacy during the First World War will appear in the Journal of Modern History in 1994. He is currently preparing a history of Compagnie Française des Pétroles in the Middle East from 1928 to 1948.

Michael French is lecturer in economic and social history at the University of Glasgow. He is the author of several publications on the U.S. and British tire industries, including *The U.S. Tire Industry: A History* (1990) and "Structural Change and Competition in the United States Tire Industry, 1920–1937," Business History *Review* (1986). He has recently begun research projects on the Albion Motor Company, a truck manufacturer in the United Kingdom, and on the Naumkeag Steam Cotton Company's marketing activities.

*Ezequiel Gallo*, who received his doctorate from Oxford University in 1970, is a member of the faculty of the Instituto Torcuato Di Tella in Buenos Aires, Argentina. He is the author of many works on Argentine social and political history, focusing particularly on the agrarian sector. These include *Farmers in Revolt: The Revolutions of*  1893 in the Province of Santa Fe, Argentina (1976) and La Pampa Gringa: La colonizacion agricola en Santa Fe, 1870–1895 (1983).

Melville Watkins is professor of economics at the University of Toronto. He has written a great deal about aspects of Canadian economic history, including a well-known article, "A Staple Theory of Economic Growth," Canadian Journal of Economics and Political Science (1963). Other works include Dene Nation: The Colony Within (1977), Canada under Free Trade (1992) (co-edited with Duncan Cameron and Daniel Drache), and, most recently, Canadian Economic History: Classic and Contemporary Approaches (1993), coedited with H. M. Grant.
