## LIBRARIES AND ARCHIVES

*AIBDA Issues Occasional Publications*—The Asociación Interamericana de Bibliotecarios y Documentalistas Agrícolas publishes the *Boletín Especial* and *Boletín Técnico* as occasional publications in collaboration with members of AIBDA in various countries. The three issues of *Boletín Especial* have focused on the activities of AIBDA and two meetings of documentalists and librarians. *Boletín Técnico*, in the two issues now published, has dealt with more specialized topics of relevance to the work of librarians and documentalists. *University of California, Irvine, Purchases Chilean Collection*—The Doddis

collection of 1,378 books on Chilean history, literature, social sciences, and fine arts was purchased by the University of California, Irvine, Library. Antonio Doddis, professor of Spanish literature at the Universidad de Chile and director of the library of the Facultad de Filosofía, had built the personal library over a period of 35 years.

*Institute of Jamaica Opens New West India Reference Library*—After years of maintaining its collections in inadequate conditions, the West India Reference Library became housed in its own new building at the end of May 1966. From its beginnings in 1895, the West India Reference Library of the Institute of Jamaica has been committed to the collection of national and Caribbean literature—the whole body of printed books, pamphlets, periodicals, maps, manuscripts, prints and photographs that trace the history of a country. Now housed in its own modern, three-story structure, the library has the largest collection on the British West Indies anywhere in the West Indies and one of the largest in the world. Comprising the smaller sections of the collection are about 600 prints, photographs, and a printed map collection numbering roughly 3000 and including maps by well-known cartographers of the seventeenth to nineteenth centuries who worked on the West Indian area (such as Visscher, van Keulan, Bellin, Moll, Jefferys, and Robertson). The main collection, however, consists of books, newspapers, and periodicals. From the point of view of research, the newspaper collection provides a valuable resource. Among the numerous volumes in it, the period 1850–1890 is particularly well covered with long runs of several papers, including the *Falmouth Post*, *St. Jago de la Vega Gazette*, *Morning Journal*, *Jamaica Guardian*, *Colonial Standard*, and the *Gleaner*. Among the manuscript collections are the Nugent papers—some hundreds of letters dealing largely with relations between Jamaica and Haiti between 1801 and 1806—and the Sligo papers, a collection of letters and documents of the Marquis of Sligo, governor of Jamaica in 1834–36. The West India Reference Library is also currently receiving some 900 periodicals, including every one now commercially published in Jamaica. Increasingly the Library is shifting attention from the repository duties of a national archive to the responsibility of providing bibliographic and indexing services that will make its collections more valuable and accessible to scholars. *Universidad Nacional de Colombia Receives Funds for Library Program*—A \$150,000 grant from the Ford Foundation was awarded recently to the Universidad Nacional in Bogotá, Colombia, to be used for library development, providing for graduate fellowships in library science, for purchases of books, equipment, and supplies, for library consultants, and for work-travel grants.

The work-travel grants provide the opportunity for eight nonprofessionals on the staff of the Universidad to be sent to large U.S. libraries for three months each. The University of Florida library is a principal point for such exchanges. Recipients are given orientation toward a centralized library system.

The Universidad Nacional has also recently received grants from U.S. AID for \$1 million for library construction, scheduled to begin in October, and \$575,000 from the IDB for library acquisitions, which will be shared with the centers in Mellín, Palmira, and Manizales.

## GRANTS, AWARDS, PRIZES

### ACLS and SSRC Sponsor Grants for Latin American Area Studies

The Joint Committee on Latin American Studies of the American Council of Learned Societies (ACLS) and the Social Science Research Council (SSRC) administers a program of grants for research in Latin American countries on the postindependence period. Grants of three types are offered. Research Grants are available to scholars possessing the PhD degree or its equivalent, who have already specialized in Latin American studies. Study and Research Grants are offered to postdoctoral scholars who may lack previous experience in Latin American studies and wish to acquire professional competence in this area by further study, language training, and field research. Preference is given to younger scholars in competition for these grants. Collaborative Research Grants, of which up to four may be awarded each year, provide support for a North American scholar and a Latin American colleague who together have made specific plans for collaboration at all stages of a research project, including choice of topic and site, research design and execution, and preparation of a manuscript for publication in Portuguese or Spanish and English. Application for the third type is made by the North American collaborator, but the grant would cover maintenance, travel, and related research expenses of both participants and their research assistants. Deadline for receipt of applications for all three types of Latin American Studies grants is December 15, 1967, for awards to be announced in February 1968. ### Aspen Award Presented to Gilberto Freyre
