# Toward a Response to the American Crisis

Glenn N. Schram



If present cultural trends continue, Americans will be unable to keep their democratic liberties. The combination of irreligion and false (gnostic) religion is paving the road to an American tyranny, possibly a totalitarian one. To reverse these trends, the author makes proposals for reform in both law and education.

A subsidiary problem is that Americans are insufficiently realistic about politics, and a new section of this expanded edition deals with political realism. Other new materials place the themes of decline and renewal in the broader context of Western civilization as a whole, and explore the limits of toleration in a society which is both pluralistic and Christianly inspired.

Unique features include a new exposition of natural law, a defense of Leo Strauss against some of the charges currently being made against him in the academic community, and an explanation of how the movies are contributing to the tyranny of the future.

# THE MINORITY GRADUATE FELLOWSHIP PROGRAM

## Purpose

In 1969, the American Political Science Association's Committee on the Status of Blacks in the Profession recognized the need to overcome the obstacles that were preventing minority students from pursuing advanced degrees in political science. The Committee recommended that the APSA work to alleviate the financial burdens of attending graduate school and to collect and disseminate information to graduate departments about minority students interested in the opportunities and challenges of higher education. The African American Graduate Fellowship Program was born. The Committee on the Status of Latinos recommended a similar fellowship program in the early 1980s, and the Latino Fellowship Program was begun in 1983. This year, the APSA Council also approved a fellowship program for Native American students.

The APSA is proud of the Fellowship Program which enriches the lives of individual fellows, brings a necessarily wider perspective to the classroom and consequently deepens—for everyone—the understanding of the discipline.

*As of 1994, the Program has helped over 40 African American and Latino political scientists earn their doctorates.*

## Eligibility

The nation's doctoral departments of political science have come to expect that APSA Minority Graduate Fellows are students of high caliber and potential. The APSA has established the following eligibility requirements:

- Applicants must qualify for acceptance in Departments of Political Science at accredited institutions of higher learning.
- Applicants must have the potential for success in graduate studies.
- Applicants must enroll in doctoral programs in political science in the United States.
- Applicants must be U.S. citizens.

Fellowships are awarded on an annual basis, and funded fellows (the top three African Americans, the top Latino and the top Native American) receive a stipend of \$6,000 for one year if a larger stipend is not provided by the awardee's graduate school.

Priority is given to those about to enter graduate school, and financial need is given major consideration. The deadline for application is December 1.

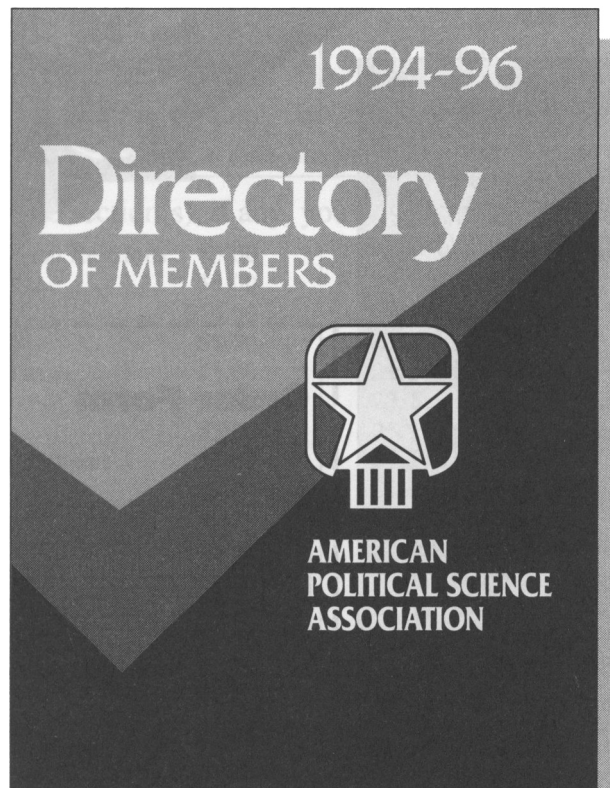

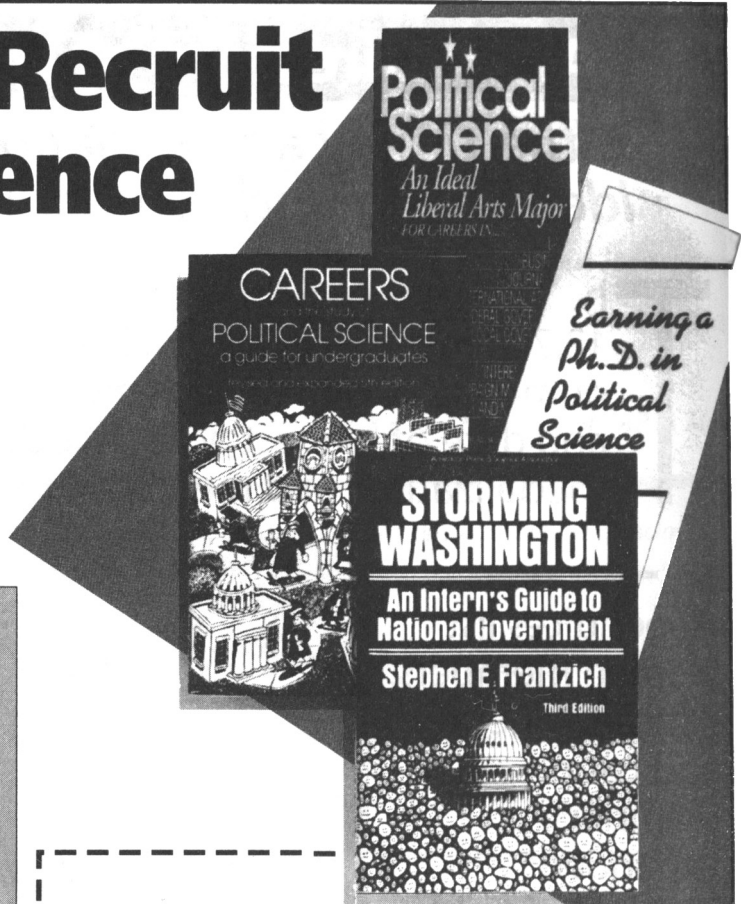
