CONTRIBUTORS

Soledad Carmina González Díaz earned her Master's degree in History at the Universidad de Chile, specializing in Ethnohistory; and her PhD in Spanish Philology at the Universidad Autónoma de Barcelona. Her research interests include Andean chronicles, colonial Latin American texts, and the ethnohistory of northern Chile. She is Associate Professor and a full-time researcher at the Centro de Estudios Históricos of the Universidad Bernardo O'Higgins, Chile. Her recent publications include "Adaptive Strategies during Times of Conflict and Transformation: Copiapó Valley under the Spanish Conquest in the Sixteenth Century," co-authored with Francisco Garrido (*Ethnohistory Journal*, 2020) and *El testamento de Josef Basilio de la Fuente. Sociedad, riqueza y redes de poder en Tarapacá, siglo XVIII*, co-authored with Jorge Hidalgo (Qillqa Ediciones, Universidad Católica del Norte, 2019).

Miguel A. Valerio is Assistant Professor of Spanish at Washington University in St. Louis. His work has appeared in several journals, including *Slavery and Abolition* and *Colonial Latin American Review*. He is completing a book manuscript on Afro-Mexican festive practices, to be published as *Sovereign Joy: Afro-Mexican Festive Practices, 1539–1640*.

Diego Javier Luis is a Visiting Assistant Professor in the Humanities Program at Davidson College. He received his PhD from Brown University in 2020 during his appointment as the J. M. Stuart Fellow at the John Carter Brown Library. He is currently finishing a manuscript entitled, "The First Asians in the Americas: A Transpacific History." His articles include "The Armed Chino: Licensing Fear in New Spain" (*Journal of Colonialism and Colonial History*, 2019), "Rethinking the Battle of Otumba: Entangled Narrations and the Digitization of Colonial Violence" (*Rethinking History*, 2019), and "Diasporic Convergences: Tracing Knowledge Production and Transmission among Enslaved Chinos in New Spain" (*Ethnohistory*, 2021).

Tamara J. Walker is a historian of race, gender, and slavery in Latin America. Her research has received support from the Ford Foundation, the Woodrow Wilson Foundation, the American Association of University Women, and the John Carter Brown Library, and has appeared in such publications as *Slavery & Abolition: A Journal of Slave and Post-Slave Studies*, *Safundi: The Journal of South*

African and American Studies, *Gender & History*, *The Journal of Family History*, and *Souls*. Her first book, *Exquisite Slaves: Race, Clothing and Status in Colonial Lima*, received the 2018 Harriet Tubman Prize. She is currently at work on two new book projects, one on the history of slavery and piracy in Latin America, and the other on black subjects in Latin-American visual culture, which will be published by the University of Texas Press.

Thomas Holloway holds an MA in Ibero-American Studies and a PhD in Latin American History from the University of Wisconsin-Madison. He taught at Cornell University from 1974 to 2000, then at the University of California, Davis, where he was the founding director of the Hemispheric Institute on the Americas and is now Professor Emeritus. He has been a Visiting Professor at the Universidade Federal de Santa Catarina, Universidade Federal Fluminense, and University of California, Berkeley. He has served as president of the Latin American Studies Association (2000–01) and executive director of the Conference on Latin American History (2002–07); and on the editorial boards of *The Americas* (1993–97) and the *Hispanic American Historical Review* (2010–15). He is the author of *The Brazilian Coffee Valorization of 1906* (1975), *Immigrants on the Land* (1980), and *Policing Rio de Janeiro* (1993), as well as numerous articles and book chapters. He is also the editor of *A Companion to Latin American History* (2008).
