In this study the author selects some 700 fragments of archival material written on wooden strips found in this century on sites occupied by garrison troops in the northwestern Han empire.

Volume I, of interest to general students of Chinese subjects and of imperial history and epigraphy, explains the archaeological and historical contexts of the fragments; the means of compiling and dispatching documents during the Han period; the Han advance toward central Asia; the organization of the Han forces.

The second volume, for scholars and historians of the Han period, sets out the evidence itself. It consists of transcriptions and translations of the most important fragments, with notes on the text and on the historical and military significance of the records.

**THE PILLOW BOOK OF SEI SHŌNAGON**

TRANSLATED BY IVAN MORRIS

The first complete English translation of one of the greatest works of Japanese literature. *The Pillow Book* of Sei Shōnagon, a Court lady of the Heian period is the earliest example extant of a typically Japanese form of writing: a collection of impressions, thoughts, descriptions, diary entries, lists of things liked or loathed, accounts of ceremonies and pilgrimages, conversations, poetry exchanges—anything to which the writer responded.

In addition to the translation, Professor Morris provides notes, ten appendices, and an index-glossary. There are also a chronology, seven maps, a compilation of the poems which appear in the text, and finding lists which serve as a guide to major versions of the text.

Volume I reproduces the pictures of the twelfth-century *Pillow Book Scroll*; Appendix 8 in Volume II consists of illustrations showing details of the clothing, houses, furniture, vehicles, and miscellaneous objects of the Heian period.

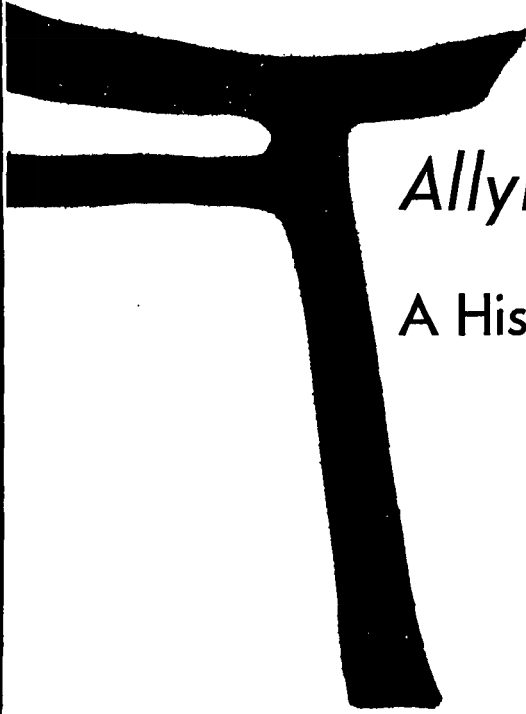

# Sam Higginbottom of Allahabad

## *Pioneer of Point Four to India*

by Gary R. Hess

A biography of Sam Higginbottom, this is essentially the story of his distinguished and remarkable career. But it is also a history of the Allahabad Agricultural Institute, which he founded and to which he devoted four decades of his life, and a survey of the development of Christian agricultural missions in India, since Higginbottom was the earliest representative of the movement and its chief promoter.

Sam Higginbottom founded the Allahabad Agricultural Institute, a unique center characterized by practical teaching, research, and extension activities, in 1910. Its success was due in large measure to the financial support Higginbottom won for it from Americans during a time when people in this country had little interest in India and to his ability to attract talented young persons to the Asian mission field. Men like Robert Pendleton, who later became the foremost American authority on tropical soils, and Mason Vaughn, who developed improved farm implements, helped the Institute to achieve major breakthroughs in the practices of Indian farming.

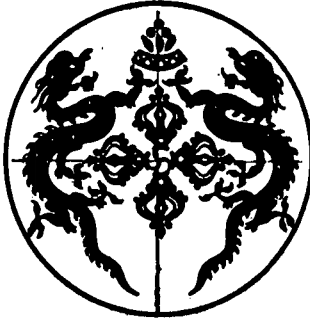

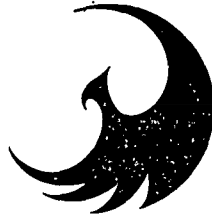

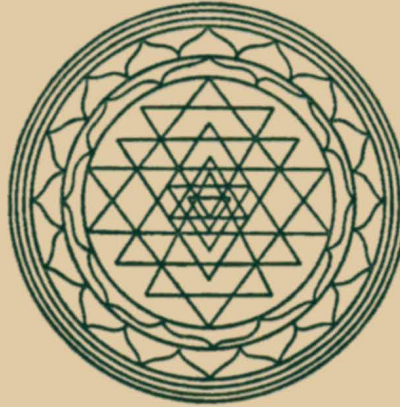
