Delphine Bechtel is a lecturer in the UFR in Germanic studies at the University of Paris IV Sorbonne and co-director of CIRCE – Centre Interdisciplinaire de Recherches Centre-Européennes. She is author of *La Renaissance culturelle juive en Europe centrale et orientale 1897–1930*, Paris, Berlin, 2002 and co-edited *Identité juive et écriture de l'histoire: Europe ashkénaze XIXe–XXe siècles*. With Xavier Galmiche she co-edited three collected issues of the journal *Cultures d'Europe centrale* published by CIRCE on the topic of outlying areas and frontier regions with a shared history, *Le voyage dans les confins*, 2003; *Le mythe des confins*, 2004; and *La destruction des confins*, 2005. A philosopher by training, he subsequently specialized in the field of communication theory and semantic analysis of political discourse. He gained a doctorate in philosophy with a thesis on the existentialism of J.-P. Sartre at Tirana University and a doctorate in information and communication sciences (University of Paris II) after defending his thesis on media and politics in Albania during the communist era and the transition. Vladimir Kolossov, who was born in 1953 in Moscow, is head of the Centre for Geopolitical Studies at the Institute of Geography of the Russian Academy of Sciences. For three years he was professor at the University of Toulouse–Le Mirail and invited professor at the Universities of Paris I and Paris IV. He chaired the Political Geography Commission of the International Geographic Union (1996–2004) and is the author of some 300 scientific publications, among them 13 books. His main field is political geography and geopolitics, but he has also studied problems of urban geography (particularly the city of Moscow) and social geography. Among his principal publications the following stand out: *Political Geography and Geopolitics* (in Russian), 2001; *The Geopolitical Situation of Russia* (ed., in Russian, translated into Italian in 2001), 2000; *The World as Seen by Russians: Myths and Reality* (ed., in Russian), 2003; *L'Atlas de la Russie et des pays proches* (co-edited with R. Michael Rywkin, professor emeritus at the City University of New York and former president of the Association for the Study of Nationalities, is the author of several books and many articles on soviet and post-soviet affairs, and on particular national issues. Olzhas Suleimenov, who was born on 18 May 1936 at Almaty, Kazakhstan, studied geological engineering, then literature. An active member of the Kazakhstan Writers Union since 1961, he was a member of the Kazakh parliament from 1980 to 1995. As a writer and a representative for the public cause and diplomacy, from 1989 he has been leading the largest popular protest movement against the former Soviet Union: the 'Nevada–Semipalatinsk' movement against the nuclear tests carried out since 1949 in the Semipalatinsk area in eastern Kazakhstan. He is the author of several poetry collections, plays, books on linguistics and articles on the development of modern societies. A large part of his work, since the publication in 1975 of the book *AZ i Ya*, focuses on relations between East and West and preserving national cultures given the challenge of globalization. Olzhas Suleimenov is a great advocate for the principles of intercultural understanding and dialogue between civilizations and religions, and for creation of a common cultural space between Asia and Europe. A former ambassador to Italy, Greece and Malta, he is currently Kazakhstan's ambassador to UNESCO. Among his publications are the following: in poetry *Transformation of Fire*, 1981; *The Language of Writing*, 1997 (in Russian); *Parallels Crossing*, 2002; *Selected Works* in seven volumes, 2004.
