Providing a guide to the lives and careers of more than 2,000 men and women who have served as governors of the fifty United States, this directory will be a valuable research aid for those involved in American studies. It includes much information not readily available elsewhere, particularly on governors who held office during the first fifty years of the nation's history. Biographies, which are written by contributors with specialist knowledge of the subject, usually contain the following information: place and date of birth and death, family background, education, marriage, professional career, and political career and influence. In addition there is a short bibliography for each individual and a note on the location of the governor's papers. Name index.

It also incorporates many changes made necessary by local government boundary alterations, the renaming or merging of institutions, and changes in ownership of manuscripts.

# LAFAYETTE IN THE AGE OF THE AMERICAN REVOLUTION

**Selected Letters and Papers, 1776-1790**

**VOLUME I: DECEMBER 7, 1776-MARCH 30, 1778**

This volume inaugurates a series that, when completed, will form a rich documentary chronicle of the Marquis de Lafayette's role in the American Revolution, illuminating the experiences, thoughts, and personality of one of the most romantic figures in America's past.

An indefatigable letter writer, Lafayette carried on a correspondence with an extraordinary range of people involved with the fate of revolutionary America. Volume I provides a fascinating account, from source materials, of his arrival in America and of his first challenging year with the Continental Army. It covers Lafayette's activities from December 7, 1776, to March 30, 1778, including his landing in Charleston, his 900-mile trip to Philadelphia, and his chilly reception by Congress. It also chronicles his service in Washington's army, his participation in the battle of Brandywine and the winter encampment of the troops at Valley Forge, and his abortive expedition to Canada in 1778.

Complementing Lafayette's personal memoirs are extensive exchanges of letters with his family and with such prominent figures as George Washington, Robert Morris, John Adams, John Hancock, and Patrick Henry. The documents and letters written in English are published as they appear in the manuscripts; those written in French appear both in the original and in translation.

Much of the basic material for this series, which will comprise six volumes, is drawn from Lafayette's own collection of manuscripts. Certain to lead to the revision of many historical judgments, the series will give an unparalleled picture of the times and help us to understand why Lafayette has remained a central figure in the American memory.

# **THE SOURCES OF ANTISLAVERY CONSTITUTIONALISM IN AMERICA, 1760-1848**

*William M. Wiecek*

This ambitious book examines the constitutional and legal doctrines of the antislavery movement from the eve of the American Revolution to the Wilmot Proviso and the 1848 national elections. Relating political activity to constitutional thought, Professor Wiecek surveys the antislavery societies, the ideas of their individual members, and the actions of those opposed to slavery and its expansion into the territories. He shows that the idea of constitutionalism has popular origins and was not the exclusive creation of a caste of lawyers. In offering a sophisticated examination of both sides of the argument about slavery, he not only discusses court cases and statutes, but also considers a broad range of "extrajudicial thought—political speeches and pamphlets, legislative debates and arguments.

Using the family as its focal point, and calling into question the usual grim picture of immigrant life, this book takes as its subjects south Italian immigrants who settled in Buffalo and its environs around the turn of the century. Professor Yans-McLaughlin examines Old World conditions and then identifies the factors that helped the Italian families to make the transition from rural peasants to urban workers.

A notable pioneer in women's education, Cornell University was the first major institution in the East to adopt coeducation, and in its early years opportunities for women were strikingly similar to those for men. Yet, as this forcefully written book makes clear, equal education for women and men was to become an unfulfilled promise. "Cornell has remained a male-oriented institution and the male ethos has prevailed," the author writes. "Women have been kept in their place."

In September 1854, Baltimoreans elected Samuel Hinks as the city's eighteenth mayor. Thus began Maryland's brief, torrid, and sometimes violent political affair with the Know-Nothing Party, which has been chiefly remembered as the originator of Maryland's "dirty" politics.

On the basis of extensive statistical research, Baker provides a wealth of quantitative data about the party's influence and activities.

Employing both economic and historical analysis, Alan D. Anderson examines the nature of urban crisis in America at the beginning of the 20th century. Rather than focusing on one of its component parts, he deals with the city as a system in which population growth, land costs, government expenses, urban services, administrative reforms, and technological developments are closely interrelated. Anderson takes as his model the city of Baltimore, which from 1900 to 1930 experienced rapid demographic, commercial, and industrial growth.

## **The Pursuit of Equality in American History**

*J. R. Pole*

The demand for equality has given the cutting edge to nearly every important movement of social protest in American history. Together with individual liberty, equality is the central moral and ideological commitment of the American Republic, the prime reason given in the Declaration of Independence for the nation's right to independent existence.

Mr. Pole seeks the meanings attached to the idea of equality by the men and women who have influenced policy and shaped the discussion from the middle of the eighteenth century to the present. He identifies certain conceptual categories, or levels of awareness: equality before the law, equality of political power, equality of religion and conscience, equality of opportunity, equality of sex, and equality of esteem.

The emergence and interplay of these themes are then examined in the great historic controversies over two centuries: the American revolution itself, agrarian and commercial rivalries, economic advance and banking in the Jackson era, slavery and race, the rise of trusts and the decline of equality of opportunity, and the complex issues of religion, immigration, and assimilation.

In conclusion the author analyses the main contributions to the public debate since the School Segregation cases of 1954—of Coleman in sociology, of the Supreme Court, of Archibald Cox and other legal thinkers in constitutional law, and of Rawls in philosophy—to name a few of the modern works examined. These investigations reveal that the alternatives before the nation's policy makers do not reduce to a straight choice between equality on the one side and some form of inequality on the other. On the contrary, the concept of equality itself has become more refined and more complex—a development that has accompanied the successes rather than the failures of egalitarian programs of reform.

# The Frontier in Latin American History

**Alistair Hennessy**

Taking the frontier as its theme, this introduction to the history of Latin America reduces to a coherent pattern the confusing variety and complexity of that continent. The author considers the sustaining myths of expansion in order to explain the original impetus behind the Conquest. He then discusses the period of consolidation when basic institutions were formed before turning to detailed examination of the various types of frontier. This analysis explores the crucial role of the frontier in the development of individual countries and highlights the ways in which it has conditioned the structure of their societies. At the same time, by questioning the assumptions of Turner's thesis on the frontier, which has coloured the interpretation of United States history, Professor Hennessy contrasts the radically different experiences of North and South America.

This book is the first on the Latin American frontier. It not only stresses the importance of an approach unjustly neglected by historians but also opens up comparative perspectives which will interest all disciplines involved in the study of Latin America.

## NOTES FOR CONTRIBUTORS

1. All contributions and editorial correspondence should be sent to: The Editor, *Journal of American Studies*, School of English and American Studies, University of East Anglia, Norwich NR4 7TJ, England.
2. Articles should generally contain about 5,000 words. Longer or shorter articles, or articles in two or more parts, may be accepted by arrangement with the Editors.
3. Submission of an article is taken to imply that it has not previously been published, and is not being considered for publication elsewhere.
4. Contributions should be clearly typed in double spacing (including footnotes), preferably on A4 paper, with a wide left-hand margin. Diagrams, maps and illustrations may be included.
5. Spelling may conform either to British or American usage, providing it is consistent throughout.
6. Footnotes should be used sparingly: in general, to give sources of direct quotations, references to main authorities on disputable questions, and evidence relied on for a new or unusual conclusion. They should be numbered consecutively, and may most conveniently be placed, in double spacing, at the end of the article.
7. For guidance on matters of style, contributors should refer either to the *MLA Style Sheet* (2nd ed.), or to the *Journal of American Studies Style Notes*, copies of which may be obtained from the Editors.
8. Contributors should keep one copy of the typescript for correcting proofs.
9. Notes intended for the Editors or printer should be on a separate sheet.
10. First proofs may be read and corrected by contributors provided that they can give the Editor an address through which they can be reached without delay and can guarantee to return the corrected proofs to the Editor, by airmail where necessary, within three days of receiving them.
11. Corrections should be kept to an absolute minimum. They should be confined to errors of the typist or printer unless the Editor authorizes otherwise.
12. Contributors of articles and review articles receive 25 free offprints. Extra copies may be ordered according to a scale of charges.
13. Contributors need not be members of the British Association for American Studies. Unsolicited typescripts can only be returned to overseas contributors who send International Reply Coupons (not postage stamps).
14. Contributors of accepted articles will be asked to assign their copyrights, on certain conditions, to Cambridge University Press, to help protect their material, particularly in the USA.
