Wayne Nafziger's political economy analysis shows how the colonial legacy, the contemporary global economic system, and the ruling elites' policies of co-opting labour, and spending on education to maintain inter-generational class, exacerbate discrepancies between regions, urban and rural areas, and bourgeoisie and workers, even under 'African socialism'. The author's policy discussion eschews technoeconomic solutions, arguing that reducing inequality requires democratising political participation as well as economic control.
