*Lena Andersson-Skog* is professor in the Department of Economic History at Umeå University in Sweden. Among her publications in English are “Compensating the Periphery: Railway Policy and Regional Interest Groups in Northern Sweden,” in *The State, Regulation, and the Economy: An Historical Perspective*, edited by Lars Magnusson and Jan Ottosson (2001); and *Institutions in the Transport and Communications Industries: State and Private Actors in the Making of Institutional Patterns, 1850–1990*, which she coedited with Olle Krantz (1999).

*Paloma Fernández Pérez* is assistant professor at the Universitat de Barcelona and member of the Centre d’Estudis en Història Econòmica Antoni de Capmany. She published *Un siglo y medio de trfilería en España* (2004) and coedited (with Pere Pascual) *Del metal al motor: Innovación y atraso en la historia de las industrias metal-mecánicas en España* (2007). She recently published an article on family firms in the Spanish metal-manufacturing industries in *Business History* (2007).

*Lina Gálvez Muñoz* is assistant professor at the Universidad Pablo de Olavide in Seville and member of the Instituto Laureano Figuerola de Historia Económica at Carlos III University in Madrid. Among her recent works are *Foreign Multinationals in the United States: Management and Performance*, coedited with Geoffrey Jones (2002); and “Regulation and Promotion of an Addictive Product: Spanish Tobacco Industry during the Expansion of Cigarette Consumption, 1880s to 1930s,” published in *Business History* (2005).

*Katrina Honeyman* is reader in social and economic history at the University of Leeds, England. Her publications include *Well Suited: A History of the Leeds Clothing Industry, 1870–1990* (2000) and *Women, Gender and Industrialisation in England, 1700–1870* (2000). She has just published a study of child workers in the Industrial Revolution.

*Angel Kwolek-Folland* is professor of history and women’s studies and Interim Associate Provost for Academic Affairs at the University of Florida. She is author of *Engendering Business: Men and Women in the Corporate Workplace, 1870–1930* (1994) and *Incorporating Women: A History of Women and Business in the United States* (1998). Currently, she is researching the international dimensions of

contemporary gender-rights categories. She is also a J. William Fulbright senior specialist.

*Ioanna Pepelasis Minoglou* is assistant professor of economic history at Athens University of Economics and Business. She coedited *Entrepreneurship in Theory and History* (2005) and *Country Studies in Entrepreneurship: A Historical Perspective* (2006). Currently she is researching the history of Greek joint-stock companies.

*Margaret Walsh* is professor of American economic and social history at the University of Nottingham. Her recent books are *Making Connections: The Long-Distance Bus Industry in the USA* (2000) and *The American West: Visions and Revisions* (2005). She guest-edited the special gender issue of the *Journal of Transport History* (March 2002) and is currently doing research on American women and car driving after the Second World War.
