## Contributors

*Marie Anghodoguy* is professor of East Asian Studies in the Henry M. Jackson School of International Studies at the University of Washington and coeditor of the *Journal of Japanese Studies*. Her most recent book is *Reprogramming Japan: The High Tech Crisis Under Communitarian Capitalism* (2005). She is also author of *Computers, Inc.: Japan's Challenge to IBM* (1989) and of many other monographs on industrial policies and the practices and institutions of Japan's capitalist system. Her current research is on Japan-China economic relations.

*Neil Fligstein* is the Class of 1939 Chancellor's Professor in the Department of Sociology at the University of California, where he is also the director of the Center for Culture, Organization, and Politics at the Institute of Industrial Relations. His main research interests are in the fields of economic sociology, organizational theory, political sociology, and the sociology of work. His books include *The Architecture of Markets* (2001) and *Euroclash: The EU, European Identity, and the Future of Europe* (2008).

*Martin Jes Iversen* is associate professor of business history at Copenhagen Business School. He is the author and editor of several business history books, including *GN Store Nord: A Company in Transition* (2005) and *Creating Nordic Capitalism: The Business History of a Competitive Periphery* (2008). Currently he is studying the strategic responses to European integration by the largest companies in a number of European countries. In 2008 he received the annual FUHU award for best teaching practices at Copenhagen Business School.

*Richard R. John* is professor of history at the University of Illinois at Chicago. His publications include *Spreading the News: The American Postal System from Franklin to Morse* (1995) and an edited collection, *Ruling Passions: Political Economy in Nineteenth-Century America* (2006). He is currently completing a history of early American telecommunications. He received his Ph.D. at Harvard in 1989, where he wrote a dissertation under the joint supervision of Alfred D. Chandler Jr. and David Herbert Donald.

*Thomas K. McCraw* is the Isidor Straus Professor of Business History Emeritus at Harvard Business School. His most recent book, *Prophet of Innovation: Joseph Schumpeter and Creative Destruction* (2007),



won the 2008 Hagley Prize in Business History and the 2008 Joseph J. Spengler Award for Best Book in the History of Economics. The second edition of his book *American Business since 1920* will appear early in 2009. His book *Prophets of Regulation: Charles Francis Adams, Louis D. Brandeis, James M. Landis, Alfred E. Kahn* (1984) won both the Pulitzer Prize for History and the triennial Thomas Newcomen Award.

*Paul Miranti* is professor in the Department of Accounting, Business Ethics, and Information Systems at Rutgers Business School—Newark and New Brunswick, New Jersey. He is currently working on two studies dealing with organizational learning. The first evaluates the development of probabilistic methodologies that augmented management decision processes at the Bell System prior to World War II. The second focuses on organizational learning at the New York Stock Exchange when it launched the computer automation of its market activities in the 1960s.

*Richard Whittington* is professor of strategic management at the Saïd Business School and a Millman Fellow at New College, University of Oxford. During 2006, he was Alfred D. Chandler Jr. International Visiting Scholar at Harvard Business School. His books include *The European Corporation: Strategy, Structure and Social Science* (with Michael Mayer, 2000) and *Strategy as Practice: Research Directions and Resources* (with Gerry Johnson, Leif Melin, and Ann Langley, 2007). He is currently working with Ludovic Caillaet on a history of strategic planning in France, the United Kingdom, and the United States.

*Mira Wilkins* is professor of economics at Florida International University. She is the author of *The Emergence of Multinational Enterprise: American Business Abroad from the Colonial Era to 1914* (1970), *The Maturing of Multinational Enterprise: American Business Abroad from 1914 to 1970* (1974), *The History of Foreign Investment in the United States to 1914* (1989), and *The History of Foreign Investment in the United States, 1914–1945* (2004). Currently she is preparing the third volume of her history of foreign investment in the United States, which will carry the story to the present. Her latest book (with William Hausman and Peter Hertner) is *Global Electrification: Multinational Enterprise and International Finance in the History of Light and Power, 1878–2007* (2008).

*Mary A. Yeager* is professor of business and economic history in the history department at the University of California, Los Angeles. Her publications include *Competition and Regulation: The Dynamics of*

*Oligopoly in the Meat Packing Industry* (1981), and “Mavericks and Mavens of Business History: Miriam Beard and Henrietta Larson,” *Enterprise & Society* (December 2001). She is currently working on an economic biography of the first tenured woman at Harvard Business School, tentatively entitled, “In the Shadow of the Big Boys: Henrietta M. Larson and the Making of American Business History.”
